Dynanet Project Highlights

The CMS Medicare Payment System Modernization (MPSM) project was created to apply modern ways of working (human-centered design, agile practices, etc.) and technologies to ensure that the fastest, most reliable healthcare payer in the country continues to meet the evolving needs of its beneficiaries well into the future.

Dynanet is building on the successful proof-of-concept it completed last year to replicate (in the CMS secure cloud) a mainframe-based query that translates between Health Insurance Claim Numbers (HICNs) and Medicare Beneficiary Identifiers (MBIs). The team conducted human-centered design research to identify use cases for Medicare Secondary Payer (MSP) data that the Common Working File mainframe application currently provides to Medicare Administrative Contractors (MACs). Team members drilled down into key business functions to understand core problems and areas where claim suspensions or denials can be reduced with better data lookups.

Dynanet is now building several MAC-facing microservice endpoints to provide MSP data with new search and filtering capabilities. Those endpoints will give MACs the real-time access to beneficiary eligibility and utilization data they need to adjudicate claims more efficiently and answer questions from providers and beneficiaries more quickly.

In March 2021, Thushara Niyangoda joined Dynanet as a Technical System Business Analyst to support the Department of Health and Human Services, Office of Inspector General (HHS-OIG) IT Portfolio Management and Enterprise Architecture program. As a Systems Business Analyst, Thushara's primary task is to analyze existing legacy systems and capture the functionality, technology stack, and interaction and integration with other OIG systems. The outcome of this analysis will be shared with the Enterprise Architecture team who will leverage it to guide OIG IT modernization efforts and will help focus on aligning the OIG mission and IT support.
