Dynanet Project Highlight: Zero Trust Working Group

In May of 2021, President Biden signed Executive Order (EO) 14028, "Improving the Nation's Cybersecurity" to support our nation's cybersecurity and protect the critical infrastructure and Federal Government networks. In January 2022, Memorandum M-22-09, "Moving the U.S. Government Toward Zero Trust Cybersecurity Principles", set forth a Federal zero trust architecture (ZTA) strategy to meet specific cybersecurity standards and objectives.

In support of our Health and Human Services (HHS) Office of Inspector General (OIG) Portfolio Management and Enterprise Architecture contract, Dynanet has been working with OIG to determine its approach for modernizing and implementing stronger cybersecurity standards that can move OIG to secure cloud services and a zero-trust architecture. Since the issuance of EO 14028 our team has been working in partnership with OIG's CIO and CTO to help develop the OIG Zero Trust Capability Model and ZTA strategy.

Dynanet is part of a newly formed Zero Trust Working Group assessing the current maturity of all Zero Trust core capabilities. The assessment will help develop a transition plan for achieving higher levels of maturity within each core capability. Additionally, it will allow us to look across each core capability's current maturity level and transition needs and gaps to prioritize across all core capabilities.

Dynanet is excited to help our customers move to zero-trust architecture. Using enterprise architecture best practices and processes we ensure a thorough assessment is completed to help shape the overall ZTA strategy and priorities prior to focusing on technical solutions.
