### Dynanet Wins NASA Contract October 2018

Dynanet was awarded a Prime contract by the National Aeronautics and Space Administration (NASA) to support the Office of the Chief Information Officer (OCIO). Dynanet will be developing strategies and policies to enable the alignment of the NASA OCIO IT Portfolio vision with the mission needs of the 10 NASA Centers. Dynanet will also be reviewing manual processes and apply Robotics Process Automation (RPA) solutions to automate them.

Dynanet's NASA team is under the executive guidance of Dynanet's CTO, Peter Anih. The Dynanet Lead for the NASA Project is Senior Enterprise Architect Ana Lombera. The additional members of the Dynanet NASA Team are John Barberio, Uzoma Kanu, Vitale Onoh, and Michael Kuhlman. Peter and the team are currently working with the NASA customer to add additional resources and support to NASA OCIO.

## Dynanet Continues Process Excellence Journey with CMMI®V2.0

September 2018

On September 21, several members of Dynanet's quality team completed one of the first U.S. offerings of the Capability Maturity Model Integration (CMMI®) Version 2.0 Upgrade Training. The training, delivered by CMMI® Institute partner, Software Quality Center (SQC), enables members of Dynanet's previous appraisal teams to serve on future ones after the old version of the model is retired in 2020. The training also gives quality team members an understanding of the new Version 2.0 CMMI® Development Model (CMMI®-DEV), which Dynanet will begin following in early 2019 as an early adopter.

The new version of CMMI®-DEV is a significant upgrade of the CMMI® product suite. It includes a better-organized model of best practices, new appraisal method, improved training and certification, more robust systems and tools, and adoption guidance to help organizations transition to the new model. The CMMI® Institute has simplified the language to make it easier to understand and apply. According to SQC CEO and founder, Kris Puthucode, "The new model also focuses more on organizational performance improvement rather than just compliance, and promises to be more cost-effective to implement, appraise and sustain, thus making the total cost of ownership significantly lower."



SQC met with quality team members and senior management before the upgrade training to kick off Dynanet's latest process excellence initiative to achieve a Maturity Level 4 rating in 2019. The kick-off meeting and follow-up session presented the concepts of higher-process maturity including advanced measurement, statistical analysis techniques, and performance prediction models.

SQC will be helping Dynanet over the next 12 months to identify performance improvement opportunities, develop statistical models for predicting expected outcomes, and establish the infrastructure needed to keep the models aligned with corporate business objectives.

CMMI® is a process improvement framework used by the best companies of all sizes across many industries. In 2017, all 5 “Fortune World’s Most Admired Companies” had at least one organizational unit with an active CMMI® rating and the Fortune #1 or #2 company in 10 different industries used CMMI®. Over 10,000 organizations in 106 countries have used CMMI® to improve their capabilities and performance.
