OPM Awards Dynanet Contract to Deploy an Automated OpenShift Environment November 2019

Dynanet has been awarded a Prime contract to support the Office of Personnel Management's (OPM) Office of Chief Information Officer (OCIO) to design, build, and deploy an automated OpenShift environment. Dynanet will partner with OPM Stakeholders to implement the OpenShift platform that will facilitate the orchestration for application development and maintenance automation.

The Red Hat OpenShift Container Platform will enable OPM OCIO to extract greater value from development and operations teams, increase frequency of software deployments, and assist in faster application development cycles while lowering total IT operations costs.

The OpenShift environment that Dynanet will engineer allows OPM to take advantage of a technology that enables micro-service level application calls to support higher transaction volume in a distributed server environment. This project will set the stage for future modernization efforts throughout the agency. "For over 11 years, Dynanet Corporation has been supporting OPM on various programs.
